Below is the email chain between Director Ruth Fanning and me about health insurance. There was a lot of confusion in local offices as to whether Voc Rehab would pay health insurance fees or require veterans to waive the insurance.

In March 2012, I met with Director Fanning to talk about the issue. At that meeting, she agreed to develop a policy letter stating Voc Rehab will pay health insurance fees when required by the college or university.

This email chain is the result of that meeting, wherein Director Fanning reaffirms her decision when I requested that my regional office in Minneapolis pay for insurance. Prior to this point, the Minneapolis office required that veterans waive the coverage.

Instead, veterans were required to place their Social Security number on the waiver form where a student was supposed to place their private insurance number. The old position was that VA care is the same as health insurance, but legally these are not the same kinds of arrangements.

This practice was borderline fraudulent since a Social Security number is not an insurance number. VA medical care is not the same as health insurance.

VA has yet to release the formal policy letter. The date of this writing is June 24, 2012.

I wanted to follow up with you to let you know we did ensure the office you are working with understands that this fee/insurance is payable if it is a standard fee for all students and that VA medical coverage is not medical insurance. We are preparing clarification to send out to the field to ensure everyone is completely clear about this issue and I will be glad to share that information with you, if you are interested.

I am still working with Steve Westerfeld regarding your guide but in the meantime, we are working on a series of articles that can be posted on VA's site that address VR&E issues.

I hope that you are doing well and that your school is progressing. Will you be attending the Detroit event?

The attached letter from VR&E Service and the Directive from the Veterans Health Administration (VHA) indicate that Veterans participating in a VA vocational rehabilitation program under Chapter 31 are eligible for necessary medical services, including dental treatment, at a VA medical facility. It is VR&E's responsibility to make the referral to VHA describing the medical issue or concern. It is then VHA's responsibility to make the determination of what services, if any, may be necessary for the Veteran to continue in and complete the rehabilitation program. VHA must provide any necessary care at a VA facility or through their Fee Basis funding. Also, VA can pay for student health fees for Chapter 31 participants in certain circumstances. VA Acquisition Regulations govern the procurement of medical services, including health care fees, outside VA facilities:

VAAR 831.7001-4 Medical services and hospital care.

(a) VA may pay the customary student health fee <u>when payment</u> of the fee is required for similarly circumstanced nonveterans

From the VR&E manual:

Medical Services Under Non-VA Health Care Contracts. The VA may pay student health care fees as a part of established school costs.

Hi Sherrie,

I wanted to follow up with you after our meeting to let you know of a major position Director Fanning took on required health insurance fees.

I met with her and Steve Westerfeld, Communications Director for VBA. Great meeting.

Director Fanning resolved that moving forward, when health insurance is required, that VR&E will pay the fee rather than to require that veterans apply for the waiver. While most universities have given VA a pass until this point, the fact is, given the ambiguity with health care between VHA and VBA, that VHA care is just not the same as insurance. Period. Claiming that it does so violates the intent of the insurance requirement, which is to ensure all students have the ability to receive care while not being concerned about payment for the care.

I just emailed her to confirm the process for facilitating the switch over. As you know, UMN does require its full time students to have insurance. Please contact me or Director Fanning with questions.

I did include the list of offices we met with while in DC at the bottom of this email, in case you were curious. The trip was a great success for veterans!
